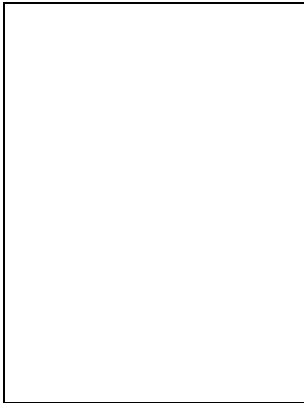

1. Once the applicant has passed the **Entrance test**, has been **interviewed by the Executive Director**, and has **accepted a place at PROTEC Pmb**, the full annual **commitment fee** of R 300-00 is immediately payable.
2. The **Code of Conduct Form** must then be carefully studied and then signed by both the **applicant and parent/guardian, and lodged with the Academy, in the applicant's file**. Special attention must be paid to the sections relating to commitment to ATTENDANCE – students who do not excuse themselves timeously, or who miss PROTEC Sessions owing to other School, Church, Family or Sporting Commitments, will have to give up their PROTEC spaces to those students who choose PROTEC as their major focus.
3. Once these simple procedures have been completed, the applicant's name will be **added to the Class List** and the applicant becomes a member of the **PROTEC Pietermaritzburg Academy community**.
4. **Stationery Requirements:** Grade 9 = 3 X 72 page A4 feint lined exercise books and 1 exam pad, ring file; Grade 10 – 12 = 4 X 2 Quire Hard-covered feint lined notebooks. Stationery MUST be provided by students themselves.
